**COMPREHENSIVE TUITION** covers the essential PPCS educational experience for the entire year. Optional Extracurricular, After School and Personal Experience activities are separately billed or paid as used (e.g. sports, clubs, specialized electives, student lunch, limited school supplies, social events, school pictures, lost or damaged items.)

**REGISTRATION FEES** are *non-refundable* and must be paid upon registration.

### **TUITION PAYMENTS:**

**10 payments plan:** First month's tuition is due on the first day of school with the remaining payments due the first of each month thereafter.

**12 payments plan:** First month's tuition is due on **June 1**, with the remaining payments due the first of each month thereafter.

**CHANGE FEE:** Any changes to a payment plan **after July 1<sup>st</sup>** will incur a \$75 change fee. Failure to pay the first installment of the 12-month payment plan by July 5<sup>th</sup> will result in an automatic change to a 10-month plan and will incur the \$75 change fee.

### **DISCOUNTS:**

**Family Discount:** Additional children in the family receive discounts of 5%, 10%, and 15% for the second, third, and fourth or more (respectively) children attending.

Discounts are given in descending order of the children's grade levels. Discount is not eligible with any scholarships, assistance, or any other discount with exception to the prepayment discount. **Prepayment Discount:** A 2.5% discount will be applied to accounts involving full year traditional where 100% of the original tuition is paid in full by the first day of school in August. Accounts that are established or paid after the first day of school, or that receive assistance, scholarship or any other discount (except the Family Discount) are not eligible. The only discount eligible for stacking is Prepayment Discount with the Family Discount, applicable to the first and second children only.

Ask the office about need based scholarships and assistance, Raise Right or Referral Credits for more tuition savings.



## TUITION CONTRACT SY 2026-27

This contract becomes effective upon the signature of the parent(s)/guardian(s), and upon payment of the non-refundable registration fee. Student(s) will not begin attendance until this contract is signed and returned. This contract contains the full agreement of the parties under PPCS policy and no representation or assurance, whether verbal or written, shall affect or alter the obligation of either party hereto. I/we refers to the parents and or guardians of registered student(s).

#### REGISTRATION FEE

- I/we understand the **registration fee is not refundable** unless admission is not approved by the school and that the registration fee reserves a class seat until full acceptance and/or the first day of school in August. After the first day of school in August the registration fee may reserve a class seat if there is no waiting list, otherwise tuition must be paid to reserve a seat. In the event the school does not approve admission, I/we understand the fee will be refunded.
- I/we understand that if the school receives a copy of orders for a military transfer or a written notice from the employer of a mandatory move decision before the first day of school, a refund of one-half the registration fee may be granted.

#### TUITION & FEE PAYMENTS

- I/we understand that failure to pay the required tuition payment on the first day of school will be cause for student(s) to be immediately disenrolled and forfeiture of the registration fee.
- I/we understand that in selecting the **10 payments plan** that the first tuition payment is due on the first day of school, with the remaining payments due the first of each month thereafter and that a late charge of \$20.00 will be assessed after the fifth day of each month a payment is not received.
- I/we understand that in selecting the **12 payments plan** that the first tuition payment is due on June 1; with the remaining payments due the first of each month thereafter and that a late charge of \$20.00 will be assessed after the fifth day of each month payment is not received.
- I/we understand that any changes made to the originally communicated payment plan **after July 1st will incur a \$75 fee**.
- I/we understand that failure to pay the first installment of the **12-month payment plan by July 5th** will result in an **automatic change to a 10-month plan** and will **incur a \$75 fee**.
- I/we understand to receive a 2.5% discount when paying the full original tuition for a full-time, traditional student, such a payment must be made by the first day of school in August and that accounts that are established or paid after the first day of school, or that receive assistance, scholarship or any other discount (except the Family Discount) are not eligible.
- I/we understand that Comprehensive Tuition includes the total cost for the required and necessary educational costs for my student and that I/we are responsible for any Optional Extracurricular, After School and Personal Experience activities that will be separately billed as used or paid individually (e.g. sports, clubs, specialized electives, student lunch, limited school supplies, social events, school pictures, lost/damaged/replacement items, late/NSF/change penalties, etc....).
- I/we understand due to the structure of the one rate Comprehensive Tuition that there are no *al a carte*/individual credits or refunds for any non-participation or absences. Late student entries or early withdraw tuition charges or credits will be prorated based on days enrolled.
- I/we understand that Comprehensive Tuition is billed and must be paid in accordance with the selected tuition payment plan (annual one time by the first day of school or the 10 or 12 monthly payments plan). Monthly payment is due the first of each month and a late charge of \$20.00 will be assessed after the fifth day of each month payment is not received.
- I/we understand additional children in the family may receive discounts of 5%, 10%, and 15% for the second, third, and fourth or more (respectively) children attending. Discounts are given in descending order of the children's grade levels. Discount is not eligible with any scholarships, assistance, or any other discount with the exception to the prepayment discount.
- I/we understand that any Optional fees (extracurricular, specialized class or elective, lost or damaged, etc...) are due on the first day of the month after being posted to my/our account.
- I/we understand Athletic/Sports fees are due prior to participation in any competitive event for the sport the fee has been billed.
- I/we understand the Family Accounts Manager will notify parents whose accounts are delinquent monthly, and payment will be expected immediately.
- I/we understand a returned check charge of \$30.00 will be assessed for the first returned check. Subsequent returned checks will result in restricting payment to cash only.
- I/we understand Board of Directors consideration of expulsion will begin once payment has been in arrears for 60 days.
- I/we understand that if my/our account is in arrears and delinquent, the school will not release or issue student records (including but not limited to attendance, report cards, transcripts, diplomas, etc...) physically or verbally until the balance is paid in full. I/we understand that since PPCS accounts are family based, this applies to the entire account and all students represented therein.
- In the event tuition and/or fees remain in arrears and unpaid and PPCS retains an attorney and/or collection agency to collect monies due, I/we agree to pay reasonable attorneys' fees and collection agency costs.

#### STUDENT WITHDRAW

- I/we understand that a **\$50.00 administrative fee** will be assessed in the event a student is withdrawn after the first day of school in August.
- I/we understand that the school will not release or issue student records (including but not limited to attendance, report cards, transcripts, diplomas, etc...) physically or verbally until any remaining balance is paid in full and all school property is returned. I/we understand that since PPCS accounts are family based, this applies to the entire account and all students represented therein.

#### ENFORCEABILITY

This Tuition Contract shall be interpreted and enforceable under the laws of the State of Colorado. If any portion of this contract is found to be unenforceable by a court of law, then the remainder of said contract shall remain in full force and effect. One parent/guardian signature constitutes a legal and binding contract.
